



# 2 N 5 children are economically disadvantaged in the Hampton Roads Region




Children living below 200% of the poverty level are economically disadvantaged and live in families that struggle to meet basic needs: food, housing, utilities, child care, and transportation.




### Virginia children of every race and ethnicity face hardship

Over time, a variety of federal, state, and local policy choices have had disproportionate impacts on families living in certain regions or belonging to certain races and ethnicities. <sup>\*</sup>FPL stands for Federal Poverty Level. The federal poverty definition consists of a series of thresholds based on family size and composition. In 2016, a 200% poverty threshold for a family of two adults and two children was \$48,600.
